Authorized users

Additional License Authorizations apply to use of the software in addition to licensing terms in your agreement with HPE or the End-user License Agreement accompanying the software. The software is a proprietary tool developed by HPE for: 1) HPE licensees and 2) HPE Authorized Service Delivery Partners for use only for the purposes of delivering HPE authorized and entitled support.

Definitions

Capitalized terms not otherwise defined in this Additional License Authorizations document are defined in the governing Agreement.

Term	Definition
<i>Appliance</i>	means an Instance of software loaded and pre-configured on a Server.
<i>Device</i>	means an addressable entity, physical or virtual, including but not limited to router, switch, bridge, hub, server, PC, laptops, handheld device or printer that resides within the range defined for interrogation and asset tracking.
<i>Instance</i>	means each implementation of the application installed on a Server.
<i>Server</i>	means any designated computer system in which an Instance or Instances of the software is installed.
<i>Use</i>	means to install, store, load, execute and display one copy of the software.

Additional license terms

The software described in this Additional License Authorization (“ALA”) is governed by the agreement set forth on the order referencing this software. The terms of this ALA shall govern delivery of the software and specifically take precedence over any different terms in such agreement to the extent of a conflict.

- A. Software contains software and associated specifications which may or may not be licensed from third parties that are confidential to, and trade secrets of, such parties. Licensee will not take any action other than to use it as authorized under the agreement and this ALA as part of the software products and will not disclose it to third parties.

- B. Licensee shall install and use the software as authorized in the applicable agreement and this ALA only as a complete product and may not use portions of such software on a standalone basis separate from the complete software or separate from the Server if delivered as an Appliance unless expressly authorized in the associated specifications or an applicable agreement.

- C. Licensee shall not access any embedded database or any other third-party product embedded in the software with applications other than the HPE Software.

- D. Licensee will not (and will not instruct, authorize or allow any third party to) publicly disseminate any performance information or analysis (including, without limitation, benchmarks and performance tests) from any source relating to the software.

- E. Licensee may not Use or allow any other person or entity to Use software or support for the provision of commercial timesharing, service bureau, managed, outsourcing, Authorized Service Delivery Partner, subscription or other services to any person or entity without written authorization from HPE, pursuant to additional terms and conditions or a separate written agreement for such Use and where applicable licenses and fees.

- F. Licensee must reproduce all copyright notices that appear in or on the software (including documentation) on all permitted copies or adaptations. Copies of documentation are limited for internal purposes only.
