DEFINITIONS

Capitalized terms not otherwise defined in this ALA document are defined in the governing agreement.

Term	Definition
E-LTU and E-Media	means products which are electronically delivered only, and as such any reference to FOB Destination or delivery methods that are stated on your purchase order other than electronic shall be null and void with respect to these E-LTU or E-Media products.
LTU	means License To Use.
Operating System	means software that controls the operation of a device such as a PC or mobile device and directs the processing of programs.
Unique Device	means an addressable entity, physical or virtual, including but not limited to router, switch, bridge, hub, server, PC, laptops, mobile device, handheld device or printer that resides within the range defined for interrogation and asset tracking.
Use	means to install, store, load, execute and display one copy of the software.
Use Case	means a specific function or set of related functions as defined by HPE or a third-party specification
Unique User	means the number of users (human and non-human) attached to the telecom network for services including but not limited to subscribers, devices, corporate users, servers and such that resides within the range defined for interrogation and asset tracking.

SOFTWARE SPECIFIC LICENSE TERMS

Software products with software specific license terms are described below.

HPE Secure Identity Broker (HPE SIB)

- The HPE SIB Software provides authentication, authorization and access control services for users (human and non-human).
- The HPE SIB Software usage is calculated based on:
 - Number of Use Cases enabled and
 - Total number of Unique Users connecting to the software.

- The supported Operating Systems and related Use Cases are separate functions. Each is licensed separately.
- The HPE SIB Software requires a separate license to a third party database and a separate license to an in memory database to operate. These licenses are available through HPE.
- HPE SIB Software can be licensed on a perpetual or consumption based model.
 - Perpetual model:
 - License is calculated based on the total number of Use Cases enabled and the total number of Unique Users accessing the platform
 - Total number of Unique Users is determined based on a three month audit period
 - Consumption model:
 - Usage is calculated based on the total number of Use Cases enabled and the total number of Unique Users accessing the platform during the agreed upon term, which can be renewed and extended as needed
 - Invoicing will occur quarterly in arrears based on actual usage. If actual usage falls below minimum usage, the pre-determined minimum usage fee will be charged.

Term

- Software may contain open source and/or third-party software and associated specifications that are confidential to, and trade secrets of, such parties. You will not take any action other than to Use it as authorized under the agreement as part of the software products and will not disclose it to third parties.
